2) In exchange for being permitted by the City of Avon to use its Facility, I hereby RELEASE AND DISCHARGE the City of Avon, its officials, directors, agents, employees, and legal representatives (“the Released Parties”), from liability for injuries and damages arising out of my use of the Facility, including any losses CAUSED BY THE NEGLIGENCE OR STRICT LIABILITY of the Released Parties. I do not release the City of Avon from liability for willful or intentional acts or punitive damages.

3) I also agree that I WILL NOT SUE OR MAKE A CLAIM AGAINST THE RELEASED PARTIES for injuries or damages sustained as a result of my use of the Facility, and I will indemnify and hold harmless the Released Parties from all claims, judgements, and costs, including attorney’s fees, incurred in connection with any action that may be brought as a result of such use. This Release shall also prevent my spouse, heirs, and assigns from pursuing any legal action or claim.

4) I agree to leave the Facility in the condition in which I found it. I acknowledge that should said Facility not be left in the condition in which it was found, I forfeit the deposit, and am responsible for any other expenses that may be incurred.

5) I understand that the parking lot between the shelter and the Fire Hall is NOT available for parking at any time.
