NOTICE: In order to offset rising costs of operations, chemicals, equipment, and debt service, water rates will go up .55 cents per 1,000 gallons used (from \$3.43/1000 gal to \$3.98/1000 gal) and sewer rates will go up \$1.32 per 1,000 gallons used (from \$7.32/1000 gal to \$8.64/1000 gal). This will become effective November 15 and will show up on your Feb 1, 2025 billing.
